simple terms.

>>>> First item to cover is this: This is my truck. Period end of discussion. There will be no liens from or by you, nor any associates of yours. There will be no instruments of any sort, by anyone that are to claim my truck as collateral today or in the future. There's no guarantee that I will be able to pay back this money in a timely manner.

>>>> Second is the amount of the estimate is in the ballpark of \$6,400.00. This is now common knowledge. No sticker shock will be allowed.

>>>> I will do the negotiation with the shop. If I believe there is a discount to be had or negotiated, I will be the final decision maker. However, I will not rebuff any commonsense discussion or advice. At no time do you have any control in the ongoing operations that are the repairs of my truck.

>>>> This arrangement does not place my truck in indentured servitude of any type or kind to you or your associates. This is a business transaction that does not become void because a person has hurt feelings; real, imagined, or otherwise. Neither I nor you have the right to forego this agreement because of travel, emergency expenditures, or other unrelated financial obligations. If such events have to occur, then the remaining balances due to complete the repairs are put into an escrow account before any such intervening events take place.

>>>> This agreement is to be conducted with as much haste as can be achieved. Obvious limitations being that of the shop and shipping.

>>>> Personal matters are not to intervene in any way, shape, or form.

>>>> This is what I will have in this agreement.
